- B. Reports:

- a. Marquette Township Board Treasurer (Ernie Johnson):
 - i. The ice rink will be closed for the rest of the winter. Township has tried to make it work, but it is too difficult to maintain.
 - ii. Working on getting some summer projects for water and sewer set up.
 - iii. Community days is set for August 12th.
 - 1. Committee of 3-4 people right now.
 - 2. Township will be hosting community days this year and will determine if they will continue depending on how it goes.
 - 3. Looking for activities for kids right now. Bounce houses are too much of a liability. If anyone has ideas, please pass them along.
 - iv. Board is looking at long term plans.
 - v. UPSET will be presenting on March 29th at 7pm, at the Township Hall. Ernie recommends anyone to attend because it is a very powerful presentation.
- b. Events Committee (Chuck Williams):
 - i. mediaBrew is taking over the Class Car Show and the Christmas tree lighting.
 - ii. There will be a couple major sponsors, but not publicly sharing who yet.
- c. Marquette Township Planning & Zoning Administrator (Erik Powers):
 - i. This is a slow time of the year.
 - ii. Expecting applications to be rolling in soon.
 - iii. Working on housing and solar plans.
 - iv. Solar:
 - 1. Right now, the guidelines for solar panel use is very strict. Same as short term rentals. Need a special use permit right now.
 - 2. Proposing that any solar use will not need a special use permit. But will still have to apply for a zoning permit. Fire department needs to have information for safety reasons. Will not need the planning commission's approval and will not have public hearings.
 - 3. This idea has been presented to the planning commission but has not been voted on yet. Will go to the Township board for final approval.
 - 4. Other interested parties will also have a say, but it will be up to the Township board to make the final decision.
 - v. Housing:
 - 1. There is a housing shortage and, in an effort, to alleviate this, they are proposing residential zone district AVUs are permitted without a special use permit.
 - 2. Also, would allow other types of housing such as duplexes.
 - vi. Renovare is looking at purchasing property behind Goodwill. 45-50 units of attenable housing proposed.
 - vii. Longyear/Forestville project is still in the works. Working with Wade Trim to complete an updated road
 - study to see what needs to be done and how.
 - 1. There will be more details to come on this.
 - 2. Not sure who is paying.
 - 3. Township has approved 20 thousand towards this.
 - 4. A study was done before but they want another done.
 - 5. This will be a PUD project eventually.
 - 6. There is a lot of land to work with, the road is just a very small portion.
 - viii. Development around Meijer will happen eventually.
